



## WATSON ELEMENTARY ACCESSIBLE PLAYGROUND DEVELOPMENT

### INTRODUCTION

The Watson Elementary Playground Committee is working to respond to the pressing need for an inclusive and accessible playground at the school. In the absence of such a space, we have children deprived of important opportunities for recreation and social activity.

With the help of the school administration and other community stakeholders, the addition of a new accessible playground will help eliminate harmful barriers to play and help promote physical fitness and social connections, fostering self-esteem and overall well-being for our students and resident neighbourhood children. In partnership with donors, we can invest in accessible and inclusive spaces that will make an invaluable contribution to our community and enrich the lives of students, families, and residents alike.

### ABOUT OUR SCHOOL

Watson Elementary is a vibrant and diverse K-5 school located in Chilliwack, BC. Our school serves a student population of over 450 and is situated across from the community of Garrison Crossing, on the Stó:lō unceded traditional territory of the Pilalt, Semá:th and Ts'elxwéyeqw tribes.

At Watson Elementary, we prioritize creating a positive, inclusive, and nurturing learning environment that encourages every student to reach their full potential. Our dedicated staff members are committed to academic excellence and are willing to go above and beyond to ensure that each student receives the support they need to succeed. In addition to our daily programming, we offer various programs onsite to further support students, including StrongStart, preschool, and after-school programs.

Watson Elementary is part of the Chilliwack School District 33, which encompasses a network of 20 elementary schools (K-5), five middle schools (6-8), and five secondary schools (9-12). The School District's facilities are attended by more than 14,000 full and part-time students and are served by approximately 1,800 teachers and support staff.



## ABOUT OUR ORGANIZATION

Watson Elementary Parent Advisory Council (PAC) is formed to be a voice of the parents to build communication and connection between home and school to support the well-being and growth of our students. Our chief mandate is to foster the social, emotional, intellectual, and physical well-being of children through the promotion of effective communication and co-operative participation between members of the home, the school, and the community.

The PAC is comprised of parent volunteers who have been elected as executives and committee coordinators, as well as all parents and guardians of registered students. We encourage all parents and guardians to attend PAC meetings to stay informed, get a chance to share your ideas, find out about volunteer opportunities, and support our great school!

As an extension of the PAC, we have delegated the task of fundraising for this project to the Playground Committee. This committee is a group of dedicated volunteers committed to bringing about these playground upgrades to create a fun, safe, and engaging playground that meets the needs of all students.

## ABOUT OUR COMMUNITY

Chilliwack, located in the Lower Mainland of southwest British Columbia, is situated about 100km away from the bustling city of Vancouver. Bounded on the north by the Fraser River and on the south by the Canada-United States border, the city is surrounded by stunning natural beauty, including tall mountain peaks, forest, and rivers.

With 8% of the population identifying as First Nations, Métis, or Inuit (FNMI), and 11% consisting of visible minorities, the city takes great pride in the rich cultural tapestry that make it what it is. In recent years, Chilliwack has experienced steady growth, with a growth rate of 8.4% over the past 5 years. The estimated population stands around 101,700, including the First Nation communities within the city boundaries.

Especially relevant for this project, there is a relatively high proportion of residents under the age of 14—accounting for 19% of the population. This highlights the importance of having access to exciting activities and services catered to this population.



## PROJECT NEED AND RELEVANT RESEARCH

Watson Elementary and its surrounding neighbourhoods, are in urgent need of an accessible and inclusive playground. The current playground equipment, consisting of two pods, was not installed with barrier-free features in mind, resulting in inadequate recreation offerings for children with mobility, developmental, or sensory limitations. The playground surfacing only exacerbates this equipment issue, as it is virtually inaccessible for those who use mobility aids.

As an example, we currently have a student using a wheelchair and is unable to play alongside her peers on the playground due to the current design and structure.

The 2022 Participation Report Card on Physical Activity reported that only a mere 6 percent of children with disabilities met the recommended physical activity guidelines for Canada, compared to 28 percent for the general childhood population. Without the development of this new playground, these children, who are already disproportionately underserved by public facilities, will experience additional barriers that prevent them from participating in physical activity and socializing—raising serious concerns for their immediate and long-term health.

# PROJECT DETAILS

In order to address this issue, our committee is collaborating with Watson Elementary and Habitat to initiative the development of a third pod focussed specifically on accessibility and inclusivity. With assistance from Habitat our vision will be brought to life as they work to provide equipment that will enable every child to fully participate and enjoy the play experience. This will be achieved by installing several features specifically designed to accommodate children of varying abilities in addition to a specially designed playground surface; the surfacing will be a combination of pour-in-place rubber and engineered wood fibre. This smooth, soft surfacing will enable easy access to equipment while augmenting the safety of the space—creating an approachable and inclusive environment that welcomes all.

At its completion, the new playground is sure to be a cherished and valuable addition to our school and wider community. At the moment, fundraising efforts are underway as we actively engage the community, local businesses, and organizations to secure the necessary finances. Through the collective effort of our community and generosity of donors like yourselves, we believe that we can reach our fundraising goal and accelerate the installation of this essential playground addition.



# PROJECT OUTCOMES

The primary aim of the playground development is to augment the existing playground by creating an additional pod intentionally designed to serve the diverse needs of children in the community, especially those with disabilities. For these individuals, and children more generally, this space will not only increase physical activity and socialization but will produce benefits that reach every aspect of their life. By providing a space suited to their needs, we are working to empower children to actively participate and engage in play that will foster a sense of accomplishment and boosting their overall self-esteem.

Through our efforts to promote and support outdoor play opportunities, we are intervening early in the lives of these children to help ensure sufficient resources are available to support healthy development; this includes improved gross motor skills, mental and emotional wellbeing, social capacity and teamwork, and learning and attention.

Beyond the four walls of the school, the new playground is expected to benefit the broader community. Our school grounds serve as a gathering place, bringing together families and residents from the surrounding neighborhoods. Improving our facilities will enhance the overall experience and satisfaction of these resident families, helping to forge a stronger community and increasing the quality of life in our city.

These considerations have important long-term implications and will have ripple effects in the community. As we work to improve the recreation facilities in the area, we are increasing the likelihood that families will remain in the area and support the local economy. Therefore, by investing in the wellbeing and inclusivity of our children, we are also building a stronger and more prosperous community for everyone.

# PROJECT TIMELINE

Ideally, we would be thrilled to be in a position to begin development in time for a fall 2024 completion. If we receive the remainder of our funding this may be a possibility, however if we are unable to secure it, we will be required to postpone this until the summer 2025.

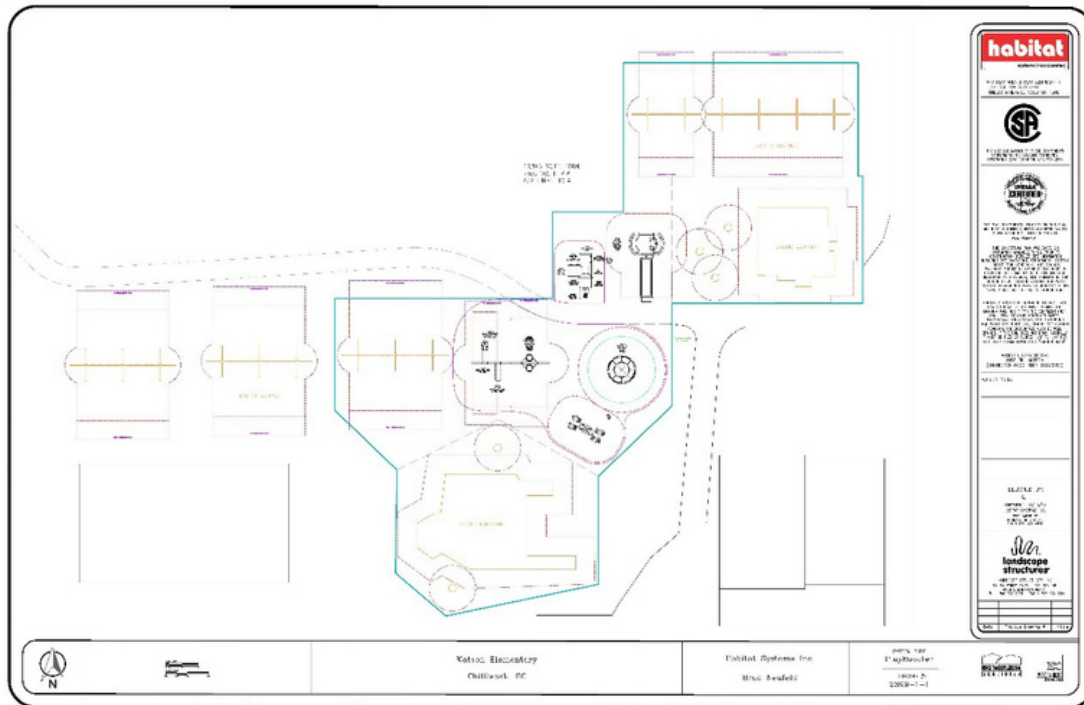

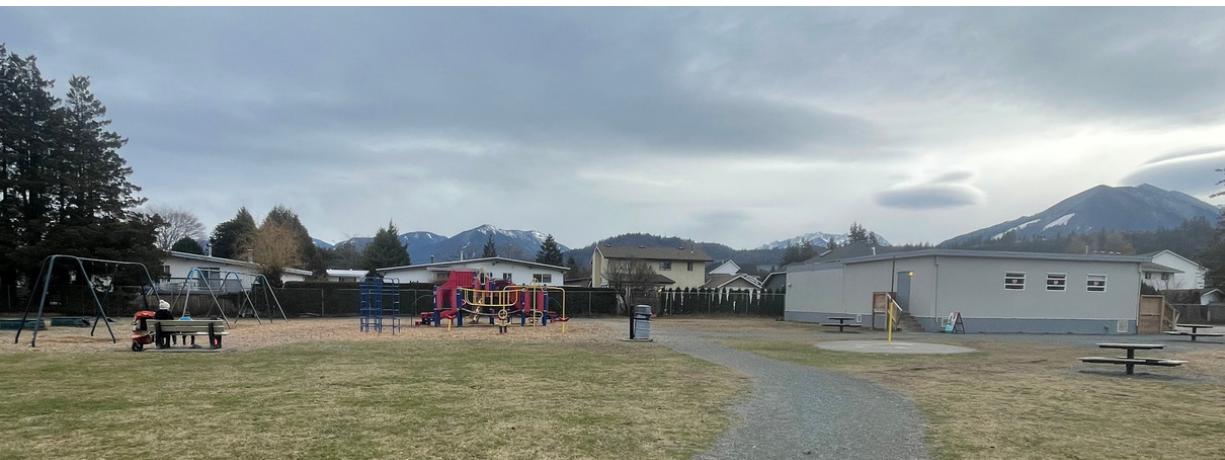


This letter confirms that School District #33 (Chilliwack) is the landowner of Watson Elementary School, located at 45305 Watson Road in Chilliwack BC.

I would like to express my full support for the Watson Elementary PAC Playground Committee in their application for funding so they can create an accessible and inclusive play space that will improve the overall health and inclusivity of its student population and surrounding community. This project would address the need for playground equipment that would be inclusive and accessible, especially for those with disabilities, developmental delays, and those who use mobility aids. It would allow the children with disabilities in our community a new opportunity to participate with their peers. There is a significant discrepancy in the weekly amount of physical activity children with disabilities participate in, as in 2022 only 6 percent of children with disabilities met the recommended physical activity guidelines for Canada compared to 28 percent for the general childhood population (Participation Report Card on Physical Activity, 2022). Those numbers are not where they need to be and creating spaces where all children can play together is an important way we can help increase children's physical activity.
